The curriculum is designed with the goal of developing a level of technical competence to prepare the student for a career as a professional accountant. The required coursework provides the student with the minimum educational requirements to sit for the Uniform Certified Public Accountant examination and other similar professional accounting certifications. The student will

receive a broad educational background which emphasizes in social responsibility and professional service. Major course work has been designed to build on the student's liberal arts foundation coursework that emphasizes reading, writing, mathematics, research, critical thinking and problem-solving.

PROGRAM ENTRY

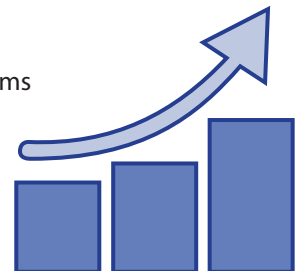

Students transferring into Briar Cliff University's Accounting program are required to have completed the accounting, Associate of Science degree from Little Priest Tribal College with at 2.0 cumulative GPA.

Little Priest Tribal College Liberal Arts, Associate of Science students may begin Briar Cliff University's Bachelor of Arts business administration degree after completing 62 credits. Students from Little Priest Tribal College will need to complete 62 credits additional credits at Briar Cliff University in order to meet the graduation requirement of 120 credits.
