Amended Tax Return Filers:

- If you used the IRS Data Retrieval Tool, we would need a copy of your signed 2021 1040X form
- If you did not use the IRS Data Retrieval Tool, we will need both:
 - A copy of your 2021 signed 1040X form
 - IRS 2021 Tax Return Transcript or <u>signed</u> copy of Federal 2021 Tax Return and applicable schedules

Option to obtain the IRS 2021 Tax Return Transcript or Verification of Non-Filing letter

- Go to your local Federal IRS tax office to request it in person.
- Get Transcript Online: Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript Online." Make sure to request the "Return Transcript" and NOT the "Account Transcript." To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.
- Get Transcript by Mail Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript by Mail."
 Make sure to request the "Return Transcript" and NOT the "Account Transcript." The transcript is generally received within 10 business days from the IRS's receipt of the online request.
- Automated Telephone Request 1-800-908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request.
- Paper Request Form IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form.
